# Terms & Conditions

### PLEASE READ CAREFULLY

Participation in the "2015 Study Hoops Euro Tour" (hereinafter the "tour") offered by NEXTPLAY SOLUTIONS Pty Ltd., trading as NextPlay Solutions (hereinafter "NextPlay") constitutes a contractual arrangement between you, the Participant (hereinafter referred to as "participant") and NextPlay, and represents your acceptance of the NextPlay Terms & Conditions set out herein. Please ensure that you read carefully and understand these Terms & Conditions prior to accepting a position on the tour if offered by NextPlay.

### Eligibility for the Tour:

- A Basketball Junkie wanting to learn from some of the best coaches in the world
  - Read and Accept the Terms & Conditions:
  - Including, purchasing your own International Airfare to the "commencement city" and,
- You must provide your own personal Comprehensive Travel Insurance
- Meet the financial obligations of the tour
- You must be 18 years of age or older, Appropriate Health to endure the rigors of international travel
- Valid Passport or the ability to obtain a Passport (with at least 6 months before expiry from the date of the tour's conclusion.)
- Have no criminal record, or reason that may result in entry to foreign ports being denies by customs officials.
- Completed Expression of Interest and Payment Option Form

### Deposit, Payment Schedule & Final Payment:

A non-refundable deposit of **\$750.00 gst inc.** per person is required to reserve a space for you. Your booking is confirmed when the deposit is received and cleared by NextPlay. You receive written confirmation from the company. NextPlay's preferred payment method is *Direct Deposit*, however payment by *Cheque*, or *Credit Card* (refer to Payment Options Form) is also accepted. Payment of the deposit indicates you have read and accepted these Terms and Conditions.

### Payment Schedule

Is outlined below. A 2<sup>nd</sup> payment of a minimum of **\$2000.00** will be required at least 90 days prior to the commencement date of the tour. The commencement date shall be recognized **as May 7<sup>th</sup> 2015**.

### Final Payment

Is due 60 days prior to the commencement date of the tour. If final payment is not received by the due date, your reservation may be canceled (refer to cancelation fee's section).

The Final Payment amount is subject to change based on currency variations and increased service provider fees. There is no change in price once the final payment date has been passed.

NextPlay is not responsible for canceled land and/or air reservations, in the event payment is not received by the final payment date.

### Late Acceptance:

Payment in full is required at time of booking for late expressions of interests accepted after the 2<sup>nd</sup> Payment date of the tour.

## Cancellations & Cancellation Fees:

All notification of cancellation for the tour must be received in writing, addressed to the Nextplay team. If extenuating circumstances occur relating to a cancellation please provide an appropriate statement, documentation outlining the reason for withdrawal from the tour.

If a cancellation notification is received by NextPlay after the deposit due date but before the final payment date of your tour, your non-refundable deposit will be retained by NextPlay in addition to any airline, hotel or tour operator-imposed fees or penalties.

## Standard Cancellation Fees:

90-119 days prior to commencement date: fees as outlined above.

60-89 days prior to commencement date: fees as outlined above plus 50% of the remaining total tour cost<sup>1</sup>.

0-59 days prior to commencement date: 100% of the total tour cost.

<sup>1</sup> Remaining total tour cost includes all tour components as well as any additional services, including extra night accommodations, independently supplied services, and optional excursions reserved prior to, or during the tour. If flight changes, including but not limited to flight cancellations or name changes, are requested after full land and air deposits are received, revision fees, change fees, or airline cancellation fees will apply (see "Revision Fees" below). In many instances, airline revision or change fees can be up to \$250 but in some instances may be up to 100% of the ticket price. Cancellation penalties will be quoted within four weeks of the time of cancellation.

NextPlay reserves the right to cancel or reschedule any departure for any reason, including insufficient demand. If the tour is cancelled by NextPlay prior to departure, NextPlay's only responsibility will be to refund the amount received by the participant for the tour minus all associated administrative costs, airline, hotel and event cancellation fee's and penalties. NextPlay cannot assume responsibility for any additional costs or any fees relating to the issuance and/or cancellation of air tickets or other travel arrangements not made through NextPlay.

## Revision Fees:

A fee of \$80.00 per transaction will be charged for any alteration or revision made to a reservation. Any revision to a booking may result in the loss of confirmed airline reservations or increased airfare which will be payable by you. Additional airline and hotel penalties may also apply and may be up to 100% of the full price. A change of traveler name, date, or itinerary within final payment will be treated as a full cancellation and new reservation; cancellation fees (as above) apply.

## Air Travel Arrangements:

Participants are responsible for booking their own *International Return Airfares* (including all airport taxes), and *Travel Insurance* and providing this information to NextPlay. International flights booked by the participant must arrive and depart from the advertised city (as advised by NextPlay) on the commencement and completion dates of the tour. Any variation to this schedule must be in writing and approved by the NextPlay Team.

NextPlay will not be responsible for any loss resulting from cancellation or changes in international gateways, itineraries or travel dates. We recommend that you do not purchase airline tickets with high penalty charges for changes. If you miss your departure flight or connection, it is your responsibility to work with the airline on which you are ticketed to reach your destination. No refunds will be provided by NextPlay for portions of trips missed due to being canceled, rescheduled or delayed flights after airport check-in, nor is NextPlay responsible for any additional expenses you may incur prior to joining the trip if you miss your departure flight or flight connection.

If you have already checked in with your airline for your first flight segment and an issue arises you must work with the airline directly to reach your destination or to make any alternate arrangements including amendments to return services. Please be aware airline fees often apply for modifications to air schedules not related to airline imposed flight cancellations, reschedules or delays. These fees will be payable to the airline directly at time of request.

NextPlay is not responsible if an airline cancels, reschedules, or delays a flight for any reason. For any air travel issues during the tour, NextPlay will make alternative travel arrangements with the participant's safety a priority along with affordability and minimizing the impact to the tour itinerary.

It is your responsibility to contact the airline prior to travel to ensure the scheduled departure time has not changed.

## Participation:

For the benefit of everyone on the tour, NextPlay reserves the right to accept or reject any participant and to remove any participant whose conduct is deemed incompatible with the interests of the other participants. NextPlay will not refund or cover any cost or expenses incurred for termination of tour arrangements due to unacceptable or illegal behavior. It is important that participants have a reasonable understanding of local laws in the countries in which the tour operates.

## Privacy Policy:

NextPlay is committed to protecting the privacy and confidentiality of personal information in accordance with the Privacy Act.

## Travelers Who Need Special Assistance On Tour:

You must report any disability requiring special attention while on tour to NextPlay at the time the expression of interest is completed. NextPlay will make reasonable attempts to accommodate the special needs of disabled travelers, but is not responsible in the event it is unable to do so nor responsible for any denial of services by air carriers, hotels, restaurants, or other independent suppliers. NextPlay cannot provide individual assistance to a tour participant for walking, dining, getting on and off motor coaches, cruise ships and other vehicles, or other personal needs. A qualified and physically able companion must accompany travelers who need such assistance and must assume full responsibility for their well being. All travelers with NextPlay are subject to the Participation clause above.

Not all sightseeing stops/sites accommodate wheelchairs and some locations and sightseeing activities require extensive standing, sitting or walking. NextPlay is not responsible for any missed activities due to a participant's inability to participate with the group. Most transportation services, including the touring motor coaches and cruise ships (if applicable), are not equipped with wheelchair ramps. With prior permission and waivers, we will attempt to accommodate motorized scooters on tour, depending on the suitability of the itinerary.

## Health:

It is your responsibility to ensure that you are aware of any health requirements for your travel destinations and to ensure that you carry all necessary vaccination documentation.

## Smoking:

Smoking is not allowed on transportation that is exclusively provided by NextPlay. Participant must be aware of local smoking laws and adhere to them accordingly.

Many hotels have imposed a 100% non-smoking policy and many cities have imposed non-smoking regulations in public spaces. As a standard rule, NextPlay confirms non-smoking hotel rooms. If you require a smoking room a request may be submitted, but we cannot guarantee availability.

## Price Policy:

The tour price is based on rates (reflecting foreign exchange rates) known at the time of publication and expected to be in effect at the time of departure, but do not include international return airfare (to and from the commencement city), your own comprehensive travel insurance, meals (outside of some breakfasts) and spending money. Tour prices are per person, based on twin-share occupancy accommodation, however please note not all locations may not be able to guarantee our preferred accommodation occupancy. Prices are subject to increase without notice, subject to the guarantees set forth below. All prices are in Australian Dollars.

Once NextPlay has received your final payment for the tour, land price is guaranteed and you are protected against any land price increase due to currency surcharge. Any subsequent cost increases are at NextPlay's expense, not including energy cost increases and/or any government tax increases.

NextPlay reserves the right to ticket bookings upon receipt of the deposit thus any subsequent changes made at your request are subject to airline-imposed change fees and/or changes in airfare price, which are your responsibility to pay.



## Visas & Passports:

You are responsible for obtaining and paying for all visas and entry documents, for meeting all health and other requirements, and for any documents required by the laws, regulations, orders, and/or requirements of the countries you will visit.

NextPlay is not responsible for providing you with specific visa and passport information or documentation, and NextPlay cannot accept liability for any passenger refused entry onto any transport or into any country due to failure of the passenger to carry correct documentation. All passengers traveling internationally are required to have a passport. Most countries require that the passport be valid for at least six (6) months beyond the conclusion of your trip. It is recommended you have a minimum of three blank pages in your passport when traveling, as many countries require blank pages. Multiple-entry visas are required for some tours. It is your responsibility to verify all visa and passport requirements. The process of obtaining a visa and/or passport can take up to three months or more.

## Hotels & Accommodation:

There is no standardized star rating throughout Europe however the equivalent of min. 3.5 star (Australia) will be booked for the tour by NextPlay.

Hotel information will be provided in future updates. If a change becomes necessary for any reason, including alternate hotels for additional departures on the same date, or hotel location changes within or outside itinerary cities, the hotel substituted will be equivalent or higher to those shown. No refunds are provided for hotel changes; full cancellation penalties as noted above apply.

Every effort is made to reserve twin-share rooms. Please note that check-in times vary worldwide; NextPlay cannot control or guarantee check-in times.

Single Occupancy maybe available in some hotels at an additional cost to the participant (outside the advertised final tour price). Please notify NextPlay if you require single occupancy and you will be notified of the supplementary fee.

## Baggage Allowance:

Airport and train station portage is not included unless otherwise specified in your travel documents. Please be prepared to carry your own suitcase on and off airplanes and trains and through airports and train stations.

Size and weight limitations for carry-on and checked baggage vary from airline to airline and even according to destination, and are becoming more restrictive. Most airlines charge fees for checked baggage and these fees are included in the airfare booked by NextPlay for travel during the tour.

NextPlay will advise participants of baggage restrictions in future newsletters.

Please note these baggage restrictions when planning your international flights to the commencement city. NextPlay is not responsible for additional fees imposed by air carriers for excess baggage. Regulations within most airports require that travelers handle their own luggage through customs. No responsibility is accepted by NextPlay for loss of or damage to baggage or any of the traveler's belongings throughout the duration of the tour. Baggage insurance is recommended.

## Carry-on Baggage at International Airports:

To increase your safety, there are new rules for taking liquids, aerosols and gels on flights into and out of Australia. These new rules are needed to protect you from the threat of liquid explosives. They are in effect as of 31 March 2007.

## Taxes:

Certain taxes are mandatory in various countries. There may also be an additional local tax charged at some airports. All taxes are subject to change without notice.

## Travel Documents:

Travel documents include (without limitation) airline tickets, hotel vouchers, tour vouchers or any other document (whether in electronic form or otherwise) used to confirm an arrangement with a service provider. Travel documents may be subject to certain conditions and/or restrictions including (without limitation) being non-refundable, non-date-changeable and subject to cancellation and/or amendment fees. All travel documents are non transferable. All airline tickets must be issued in the name of the passport/photo identity holder, some carriers will deny carriage if the name varies and the booking may be cancelled. NextPlay will be responsible for sending travel documents to the participant, however some documentation may be sent directly from travel agents or tour operator's.

**Not Included in the Tour Price:**

Airport taxes and fees on international return flights (to tour commencement city booked by participant)

Comprehensive Travel insurance is required. NextPlay can provide an acceptable product through Flight Centre.

Meals, excluding some breakfasts and other meals as notified by NextPlay

Passports; visas and vaccinations;

Tips to the Local Hosts, driver, Local Guides, and/or ship's crew; gratuities on ferries, trains, and cruise ships; laundry; telephone; minibar; alcohol, beverages, optional excursions; airport transfers on non-qualifying flights; portage at airports and train stations; Travel Protection; baggage fees; and all other items of a personal nature.

**Refunds:**

Please note that any request for refunds is subject to these Terms & Conditions; no refund will be made for unused services. Any refund entitled to the participant pursuant to the terms and conditions of this tour may take up to twelve weeks to process.

Airport transfers are complimentary with air travel booked by NextPlay as well as on arrival and departure from the commencement city. Customers not using the included transfer will not be given a cash equivalent or tour price reduction.

**Service Inquiries After the Tour:**

After returning from your tour, if you wish to inquire about any services provided, please ensure that all correspondence relating to those services is received by NextPlay (see address under "Responsibility").

Any complaint or claim involving the tour services offered must be notified to NextPlay within 30 days of the tour completion, except where such time limitations are prohibited by law.

As it is difficult and sometimes impossible to properly investigate a complaint if NextPlay is not advised of such complaint quickly, any compensation you may have been able to claim could be reduced or even forfeited if you do not follow the complaints procedure set out in this clause.

In the event of a problem or complaint involving the negligence of any suppliers, sub-contractors, or agents in relation to any service provided to the tour participant, NextPlay must receive the complaint while on tour or within 30 days of tour completion.

**Holidays:**

During local or national holidays or special events, on Sundays, and religious occasions, certain facilities such as museums, churches, restaurants, sightseeing tours, and shopping may be limited or not available. Alternatives will be offered whenever possible. NextPlay cannot be held responsible for any closures or curtails for any reason.

**Safety:**

Please be aware that during your participation in tours operated by NextPlay, certain risks and dangers may arise beyond our control, including but not limited to: the hazards of traveling in undeveloped areas; travel by boat, train, automobile, aircraft, or other means of transportation; forces of nature; political unrest; acts of lawlessness or terrorism; and accident or illness in remote regions without means of rapid evacuation or medical facilities. NextPlay will not have liability regarding provision of medical care or the adequacy of any care that may be rendered. While NextPlay will use its best efforts to ensure that adequate measures are taken, by agreeing to participate in a tour and/or optional excursions you agree that you will hold NextPlay harmless regarding any provision of medical care or the adequacy of any care rendered.

**Photographs or Pictures:**

Photographs or pictures used to promote the tour should be used solely as an indication of facilities and attractions. Actual facilities and attractions may vary according to itinerary.

Photographs taken during the tour by NextPlay will be used solely for the purpose of promoting the company and future tours. Consent of the participant/s will be requested but no financial compensation will be provided.

NextPlay has no liability for any such optional activity or excursion or for any act(s) or omission(s) of the organizer or operator or for any of its employees or agents or any other person(s) connected with the optional activity or excursion.

Any advice or assistance on or with any Service provided by any local representative does not mean or imply that the Service is sold, supervised, or controlled by NextPlay or that any such advice or assistance is given on behalf of NextPlay. Tour participants are asked to check with the operator of any optional activity or excursion and the applicable Terms & Conditions before booking.

## Company Responsibility:

NEXTPLAY SOLUTIONS PTY LTD, is an independent company registered under the Australian Securities and Investment Commission (ASIC) providing Coaching and Consultancy services under the NextPlay Solutions brand name. The 2015 StudyHoops EuroTour is a coaching product provided by the company.

Air carriers, accommodations, and other suppliers (including but not limited to trains, cruises, ferries, motorcoaches, hotels, and restaurants) providing services are independent contractors and are not agents, employees, servants, or joint venturers of the Company or its affiliates.

The international carriage of passengers is subject to international conventions and treaties, where applicable. These international agreements limit and, in some events, exclude the carrier's liability to passengers (tour participants). Where any claim or part of a claim (including those involving death or personal injury) concerns or involves any travel arrangements (including the process of getting on or off the transport concerned) provided by any air, sea, inland waterways, rail, or road carrier or any stay in a hotel, the Company's maximum liability is the maximum which would be payable by the carrier or the hotel keeper concerned under the applicable international convention, treaty, or regulation applicable to the travel arrangements or hotel stay (e.g., the Warsaw Convention, the Montréal Convention for international travel by air, the EU Regulation on Air Carrier Liability for air carriers with an operating license granted by an EU country, the Athens Convention for international travel by sea) in that situation.

After departure, if the services included in the tour cannot be supplied or there are changes in an itinerary for reasons beyond the control of the Company, the Company will arrange for the provision of comparable services. Any resulting additional expense will be the responsibility of tour participants, and any resulting savings will be refunded by the Company to tour participants.

The Company reserves the right to accept or reject any person as a tour participant; to expel any participant from the tour; to make changes in the itinerary whenever the Company deems it necessary for the comfort, convenience, or safety of the participants; and to cancel a tour at any time.

The tour participant agrees that neither the Company nor its affiliates shall be liable for any damage, loss (including personal injury, death, and property loss), or expense occasioned by any act or omission of any supplier providing services, any insurer or insurance administrator, or any other person.

Every reasonable attempt should be made between the Company and the Participant to resolve any dispute relating to the Terms & Conditions. Failure to produce a mutually agreeable outcome should result in further action taken by either party in accordance with the law.

Arbitration against the Company must be commenced within one year following the date of tour completion. Neither the Company nor any affiliate shall in any case be liable for other than compensatory damages, and you hereby waive any right to punitive damages.
